5	CHAIRMAN COOK: Let us convene the May meeting of the
6	Nevada State Dairy Commission.
7	Mr. Hettrick, would you begin proceedings, please?
8	MR. HETTRICK: Yes, sir.
9	Mr. Chairman, this is the time and place set for a
10	regularly scheduled meeting of the Nevada State Dairy Commission
11	for the month of May, 2012.
12	This meeting has been scheduled and noticed in
13	compliance with the pertinent statutes, including the open
14	meeting law.
15	A copy of the agenda has been handed to the court
16	reporter, with the request that it be a part of the official
17	transcript of these proceedings.
18	My name is Lynn Hettrick, executive director of the
19	Nevada State Dairy Commission.
20	Present today are Mr. Christopher Cook, chairman.
21	Mr. Troy Crowther, member of the commission.
22	Mr. Bob Fletcher, member of the commission.
23	And certain members of the Dairy Commission staff.
24	Those who present statements or evidence to the
25	commission during this meeting are requested to first be

1	acknowledged by the chairman and to identify themselves for the
2	record.
3	CHAIRMAN COOK: Please proceed with the first agenda
4	item.
5	MR. HETTRICK: First item on the agenda, Mr. Chairman,
6	is public comment and discussion.
7	We only have one member of the public here.
8	PERSON IN AUDIENCE: We're good.
9	CHAIRMAN COOK: Okay. Let's press on.
10	MR. HETTRICK: All right. Next is the report on the
11	Clark County Fair.
12	MR. SHAFER: You guys are throwing me into the fire,
13	huh?
14	MS. WILLMOTH: Tell me when.
15	MR. SHAFER: I'll tell you when. Do I need to state my
16	name and everything, or can I just go?
17	CHAIRMAN COOK: Probably you should state your name for
18	the record.
19	MR. SHAFER: Mike Schafer, Nevada Dairy Commission,
20	environmental health specialist.
21	Kathy and I attended the Clark County fair from the
22	12th through the 15th. It's up in Longandale.
23	I have the miles wrong. It's closer than that, but it
24	seemed like 90 miles for me to drive every day.
25	So, we returned all four days. We were located in the

1	small animal pavilion, which I was a little surprised about.
2	Lot of roosters and chickens and ducks and geese are
3	quacking and crowing all day long, so that was kind of
4	interesting.
5	MS. EASLY: Don't forget the cows.
6	MR. SHAFER: We had cows, peacocks, turkeys, Guinea
7	pigs, gold fish, pigs, goats, lambs. I mean it was just nonstop.
8	So, um, all four days went real well. We got up there
9	at nine each day and set up the table.
10	I will have some pictures here in a second. Fair
11	started around ten, and the first two days, like Thursday and
12	Friday especially, we got hit right away with teachers bringing
13	in students, just loads and loads of students, those first two
14	days. So, it got busy right away.
15	Then it would die out for a while.
16	I looked up the numbers. It was about 62,000 that
17	attended over the four days.
18	Let's see. Kathy did the cow suit. I refused to get
19	in that. It was too hot. But she did real good, you know, she
20	did like an hour block at a time and then she would change out of
21	it and then get back in it later.
22	We kind of did it just based on the crowd, based on
23	like if we saw if it was busy or if there was kids coming in.
24	Took over a thousand pictures. We had people, I mean
2 5	we had adults all the way like infants everyhody wanting to

Page 6 take pictures with her. I mean it was just once they saw that, 1 it was nonstop. People just waiting in line, handing her their 2 children, everything. I mean was crazy. So. 3 4 CHAIRMAN COOK: I see a second career for Kathy at 5 Disney World. MR. SHAFER: No, she did fabulous. 6 It was pretty warm up there and it was dusty and, you 7 know, and dirt and she did good, you know. 8 I was impressed. I couldn't have done it. It was just 9 10 nonstop. People coming up. 11 We got a real good response. And some of the fair 12 people actually came over, the guy that was running our pavilion, and said, you know, basically, thanks. You guys are great. 13 14 You're outgoing, you know, you're interacting with people. You know, we're really glad that you're here. 15 16 And that was the response we got from pretty much everybody. So, so along that line, yeah. Just, you know, she 17 18 would get in the suit, and then I was just telling people, "Hey, come take your picture with Moolissa. Come find out what the 19 Dairy Commission does." And just talking with people. 20 And most of the questions we had are things like, you 21 know, well, what does the Dairy Commission do? What do you guys, 22 you know, a lot of people thought we were the Dairy Council. 23 They got kind of mixed up a little bit, so, you know I just kind 24 of explained what our job is and, you know, kind of what we do as 25

2	You can switch to the next slide.
3	MS. WILLMOTH: I haven't switched to any slides.
4	MR. SHAFER: We just handed out a lot of stuff. People
5	taking the stickers and the pencils and coloring books.
6	We would have lines of people at the table just waiting
7	to take stuff. So, it got pretty fast and furious for a few
8	hours each day.
9	Saturday we had the Dairy Council girls, I guess
10	somebody set them up. At the time we weren't really aware they
11	were coming, so we had six people, or five people from the Dairy
12	Council on Saturday.
13	So, I think next year we'll try to work out where maybe
14	we can split those days up because with five of them and two of
15	us, you know, it got, there was too many people, you know.
16	But, they brought up cheese sticks and some other
17	products they were handing out, so that was good, and just
18	interacting with people, taking pictures with the suit.
19	Is that up? Our slides, Gayle?
20	MS. EASLY: There they are. That's the gals.
21	MS. WILLMOTH: There they are. You have to queue me.
22	MR. SHAFER: I don't see anything on our end. That's
23	what I was asking.
24	MS. WILLMOTH: You might have to move your video.
25	They're behind your video. The slides will be up.

1	MR. SHAFER: Yeah. I have our video off to the side.
2	MS. WILLMOTH: Huh. It's up here.
3	MS. EASLY: It's the picture of the girls right now.
4	MR. SHAFER: Oh, okay. Well, you can just flip through
5	those. It would be nice if Troy could see them here.
6	MS. EASLY: This picture is a picture of the milking
7	cow that we have inquired about getting for our, for the Dairy
8	Commission.
9	As you can see
10	MR. SHAFER: Yeah, that milking cow, that was one of
11	the first things people saw when they came in. And the kids were
12	lined up to do that.
13	I mean it looked like a real good thing to do. I'm
14	going to try to see if I can find this here.
15	CHAIRMAN COOK: Whose cow was this?
16	MS. EASLY: Was that the Farm Bureau's?
17	MR. SHAFER: Yes. Wait. Do this again. Like right
18	there, the middle one. Yeah, right there.
19	Okay. So, yeah, there's some pictures of the kids
20	doing the milking, and then they would always come over to us
21	right afterwards.
22	Do you want to back up a couple so Troy can see what
23	the table looked like and stuff?
24	Keep going.
25	Yeah. One more.

1	Yeah, right there. So, that's kind of our booth. We
2	had a really big area to work with.
3	CHAIRMAN COOK: That's the same display we had in
4	Tulare?
5	MR. CROWTHER: I was there and I missed it. I was
6	there Saturday at the small animal pavilion, and I must have gone
7	another way or something. I would have stopped by and said hi.
8	MR. SHAFER: So, you guys can see right behind us we
9	had two cows. And that cow was unhappy the entire time. It
10	wasn't from here. It was mooing constantly. So, that was fun.
11	Okay. Next slide.
12	So, that's what our table looked like in the morning
13	when we first got set up. We had some other materials from some
14	other agencies that were there, so we kind of shared in, all of
15	us handed out each other's stuff sort of.
16	So, next slide.
17	So, there's how many people we had, plus Kathy and
18	myself in that area, so you can see it was a little crowded and,
19	but they were helpful. They were all very outgoing and stuff, so
20	it helped.
21	COMMISSIONER CROWTHER: That must be Saturday.
22	Saturday was cold.
23	CHAIRMAN COOK: I was going to say it doesn't look like
24	it was hot.
25	MR. SHAFER: Saturday was nasty, but every other day

2	That's milking of the fake cow there.
3	You can go to the next one.
4	So, there's Kathy in the Moolissa outfit. The pictures
5	are hard because the sun was coming in on the upper part of the
6	barn.
7	So, but, and then that's just like people, you know, I
8	was just trying to show how crowded it was there at the table all
9	the time.
10	So, you can go to the next one.
11	There's Kathy with a baby goat, and then the little
12	girl on the right was a girl named Lilly who we befriended there.
13	She was one of the 4-Hers, and she was probably at our table ten
14	to 12 times all day long each day. So, she was a nice little
15	girl. That was her showing her chicken there that day. So, she
16	was just fun.
17	Next slide.
18	Those are a sampling of some of the animals I took
19	pictures of.
20	By day four, it got kinda smelly in that barn. I was
21	glad to be done.
22	So, there's the peacock. I thought that was a good
23	picture there. And obviously the turkeys. And then so this is
24	how I ended my Sunday. I played chicken bingo.
25	Do you guys want me to explain it?

1	MS. EASLY: Go ahead.
2	MR. SHAFER: So, they put the bingo card in there and
3	everybody buys a square for two dollars. The money goes to 4-H,
4	and then they throw feed in there, and they throw a chicken in.
5	And wherever he poops, that number he poops on wins.
6	You get \$50 and then the other 50 goes to the 4-H
7	group. The first chicken up on top rooster, I'm sorry. The
8	first rooster didn't do anything, and we waited and waited, and
9	then finally they threw in the white one, and he finally went.
10	It took about 10, 15 minutes. So, that was fun. We had a hard
11	day on Saturday. I just thought I'd throw that in.
12	I think that's about it. Do you guys have questions?
13	MS. EASLY: We also helped out with the butter carving,
14	and Mike actually got to be one of the judges on the carvings.
15	MR. SHAFER: I'm a city slicker, and I didn't know
16	about butter carvings and chicken bingo and all this stuff.
17	So, it was an experience, you know? I got to wear my
18	plaid shirt and stuff and so, yeah. It was fun. We did butter
19	carvings like twice a day and we judged those, and give out
20	ribbons and stuff, so.
21	MR. CROWTHER: Did you go to the pig races?
22	MR. SHAFER: We did not get over to the pig races.
23	MR. CROWTHER: That's the highlight.
24	MR. SHAFER: Kathy and I were busy. The entire time.
25	MS. EASLY: Even our lunches. We would go get

Page 12 something and bring it back and eat it at the table in between 1 talking to people. 2 I mean I was just amazed at how many people came to our 3 4 booth. And Mike would literally stand behind me with his 5 hands-on my back, because the kids would come rushing at me. 6 And he kept me from falling over many times. 7 MR. SHAFER: The people don't realize she would lose 8 her balance. 9 A couple of things we kind of figured out. You know, 10 11 if we do this again next time, we need something, one of those 12 like changing, where you stand behind to change clothes because we didn't want to do it in front of the children, because we 13 thought that might be kind of weird, seeing somebody get into a 14 cow suit right in front of everybody. 15 So, we had to take her out back, and then to walk her 16 through the whole pavilion. It got a little tricky because it 17 18 was a dirt floor and stuff. So, we thought maybe getting one of those changing things where you can just stand behind it and 19 change? I don't know. 20 MS. EASLY: And we would literally have a train of kids 21 behind us as we walked through. It was fun. It was fun. 22 MR. HETTRICK: Once they saw her walk in, everyone 23 tends to focus on her. And they would follow her all the way 24 25 back to the booth.

Page 13 We actually had to get her in a chair for a while. She 1 got tired of standing, there was so many kids swarming around 2 3 her. 4 CHAIRMAN COOK: Did you drive down there? 5 MS. EASLY: Yes. CHAIRMAN COOK: So that's how you transported the 6 7 costume. MS. EASLY: Yes. The costume, and the banner, and some 8 9 supplies for Libby's groups. 10 MR. GOEDERT: I thought you would show up on a 11 motorcycle. 12 MS. EASLY: If I could have figured out how to put her head on the motorcycle, I would have. 13 MR. SHAFER: We had, did have some kids, the older ones 14 wanted to get in the suit. We did like, what did we do, Kathy, 15 15 minutes or something like that, or 20 minutes? 16 17 MS. EASLY: 20 minutes. We didn't let them stay longer 18 than 20 minutes. MR. SHAFER: We had three or four that actually 19 volunteered and wanted to be in it. They were begging us. So, 20 we gave Kathy a break and we let some of the 4-Hers in and they 21 did that for a little while. 22 So, it went really well. We had a lot of people coming 23 up telling us stories how they used to be a milkman in the old 24 days, or they used to work on a dairy. Just random stories just 25

Page 14 all day long. So, it was good. 1 CHAIRMAN COOK: When we're at these kinds of things, do 2 we get people to sign-up for the e-mail version of the monthly 3 4 newsletter? MR. HETTRICK: We handed out all kinds -- we had a 5 coloring book, we had 500 copies. 6 MS. EASLY: I had 500 copies of the coloring book gone. 7 Libby gave us five boxes of 14 each of pencils. Gone. 8 I mean, her coloring books were almost gone. 9 She had two cases of them, and they were almost gone. 10 11 We even gave out some of the Beef Council's coloring 12 books towards the end there, because we didn't have any of the others left. 13 14 MR. HETTRICK: Do we have our website on the coloring 15 books and those kind of things? 16 MS. EASLY: I believe we do. I can give you a copy of it. 17 18 MR. SHAFER: Kathy made a stack of calendars she printed out up, and you wouldn't believe just a one-page 19 20 calendar, and people snapped those up. MS. EASLY: Gone. 21 But, it just seemed everything we put in, Libby sent 22 down fans, three cases of fans, and gone. I mean. 23 MR. HETTRICK: Yeah. They could give out everything we 24 And I think a lot of it does have our web site, and those 25 had.

Page 15 kinds of things on it. And I do monitor that on Google 1 analytics. And we've been doing quite well. The hits on the web 2 site are running, probably several hundred a month, where we used 3 4 to get three in six months. 5 CHAIRMAN COOK: Was there any sort of a spike up following this appearance? 6 MR. HETTRICK: I just looked yesterday at the last 30 7 days, and would that have covered it? I don't remember seeing --8 yeah, that it would have been. 9 MS. EASLY: It would have been in April. 10 11 MR. HETTRICK: It would have been from April 7th to May I didn't think I saw any particular spike, it didn't look 12 7th. like any particular spike. But, the hits have been up, so it's 13 14 hard to tell. Anyway, it's good. We're getting some recognition, we 15 are getting some out there, getting to talk a little about milk 16 safety and, you know, milk quality, and all those things. 17 18 Good things. And they really appreciated having us there. I mean that was the first thing the gal said when they 19 came back. They said, boy. We really appreciated you being 20 here. And you really drew a crowd. And we would like you to 21 come back. Those are good things. You know. 22 23 MS. EASLY: And we have scheduled on May 18th for a 24 school fair for Moolissa to go to. CHAIRMAN COOK: In the north or in the south? 25

1	MS. EASLY: Here. In Reno. So, she's getting active.
2	CHAIRMAN COOK: Is there any way we can incorporate the
3	processors into this? And get them some exposure as a result
4	of
5	MR. HETTRICK: Well, we certainly would hand out
6	things, as long as we weren't promoting individual. If everybody
7	had
8	CHAIRMAN COOK: If we had everybody. Model, Meadow
9	Gold, Anderson and, everybody, and we're not pushing any
10	particular one, we're just telling you about local milk.
11	MR. HETTRICK: To the extent we can do it, I mean yes.
12	I don't know how well that works between north and
13	south and some of those things. But, as long as we don't get any
14	flack from anybody that we're promoting somehow business with
15	state personnel, they'd yell at us.
16	But, other than that, I mean if there's something we
17	can hand out or somebody wants to have, you know, I would suppose
18	as long as it was offered to everybody and they all had an
19	opportunity to come up with something, a display or something, we
20	could.
21	But, I don't know what would happen. There's 30 or 40,
22	ultimately, people who process dairy products, we probably have
23	to offer it to all. If they all gave us something, I don't know
24	how we would deal with it.
25	So, it might be a problem. We just need to look at

Page 17 that. We're certainly happy to promote anything local and local 1 businesses, but we have to be careful with what the State will 2 let us do. 3 MS. EASLY: And we also worked with Zac Allen at the 4 Nevada Farm Bureau Federation, and Zac sent me this letter that I 5 gave you a copy of, explaining about the fair. And he seemed 6 very happy that we were there as well. And he's planning for 7 next year already to work with us. 8 9 CHAIRMAN COOK: Okay. 10 MS. EASLY: We're excited. I was very excited. 11 MR. SHAFER: I had fun. By the fourth day I was ready to be done with it. 12 MS. EASLY: I got real tired by Sunday. 13 14 CHAIRMAN COOK: I'm sure you did. MR. SHAFER: You know, I had an hour and 15 minute 15 drive on each end, and we were there until seven every night at 16 least, once the rodeo started, the crowds really died out in the 17 18 pavilion, so we would have to pack up, and then we would take the suit out to the car. 19 20 So, they were long days. But, it was fun I had a good 21 time. MS. EASLY: We left the banner up there, but I just 22 didn't feel safe leaving Moolissa there. So, Moolissa went home 23 with me every night. 24 CHAIRMAN COOK: Now the most important question. 25 Who

Page 18 had to refill the cow? The milking cow? 1 MS. EASLY: I have no idea. Actually, I think it's on 2 a system where they milk and it comes out of the bucket and goes 3 4 back in. 5 MR. SHAFER: It wasn't even milk, Kathy. It just recycles through the cow and back up. 6 Any other questions or anything? 7 CHAIRMAN COOK: No, I don't have any. Thanks, Mike. 8 9 MR. SHAFER: Okay. Good. 10 MR. HETTRICK: Thanks, Mike. 11 MR. SHAFER: No problem. MR. HETTRICK: Kathy has always got to do this. We're 12 going to let Mike play this time, get him involved, since he 13 14 helped go out there and do all this. So, we thought it would be 15 good. CHAIRMAN COOK: Okay. Well, let's press on to the next 16 agenda item. Thank you, Kathy. 17 18 MR. HETTRICK: All right. What I'd like to do, Mr. Chairman, is skip over. Because if I do my staff report, you 19 will get a better explanation, perhaps, for item three on the 20 21 agenda. So, and we are allowed to do that, I will just note on 22 the bottom of our agenda, it does say items may be taken out of 23 24 order. So, I want to make sure nobody thinks we're doing something incorrectly. 25

Page 19 Let's jump, if we may, to item number four, approval of 1 the minutes. The minutes are in the packet there. Two minor 2 corrections. And with those included, if you want to approve the 3 minutes, Mr. Chairman, that would be good. 4 COMMISSIONER FLETCHER: Mr. Chairman, I have a question 5 about another one. On page nine, line 23. I'm just questioning 6 if that's the way you wanted to word that, Lynn. 7 MR. HETTRICK: I haven't got a copy of the minutes in 8 front of me, so I'm going to have to look. 9 COMMISSIONER FLETCHER: Okay. I'll withdraw that. 10 MR. HETTRICK: It should be, "dairymen," so if we can, 11 let's add page nine, line 23, change "dairyman" to "dairymen". 12 And with that change included, if you would like, Mr. Chairman, 13 14 you can make a motion. CHAIRMAN COOK: Okay. I will entertain a motion. 15 MR. CROWTHER: I will make a motion to approve the 16 minutes of the Dairy Commission meeting on, held on April 18th, 17 18 2012 with the indicated corrections. 19 COMMISSIONER FLETCHER: Second. CHAIRMAN COOK: Okay. Having a motion and second and 20 no dissenting votes, the motion carries. The minutes are 21 22 approved. MR. HETTRICK: Okay. Mr. Chairman, we'll go to number 23 five, agenda item. It's the staff report for May 2012. 24 Our balance carry forward for April was 417,328.31. 25

Page 20 That's a decrease of 13,848 from March. We anticipate that the 1 June tax credits that we want to talk to you about shortly will 2 move our reserve to below 400,000. 3 The reserve recommended by the LCB is for all, for 4 general fund agencies is three months of expenses. And for us 5 they have recommended a maximum reserve of 321,960 for the years 6 2011, 2012. 7 We've already reduced our reserves by more than 8 \$200,000, anticipated through the budget cycle, and since we have 9 demonstrated the willingness and the ability to reduce the 10 11 reserves, our plan now is if you approve the tax holiday that we 12 propose, we will propose here in just a moment, it will drop our reserves below 400,000, somewhere between the 320 and 400. 13 14 And we'll probably just sit then and see how things go. And then we will adjust, as I say, we have shown the willingness 15 and the ability to adjust, so we will just probably sit and just 16 see how things go for a little bit, and then decide what we need 17 18 to do down the road. So, that's the report on the reserves. The milk price 19 report doesn't come out until the 10th, which is tomorrow, so we 20 don't have a current pricing. The pricing, Bob, that we are 21 aware of is what we gave to you at the last meeting. 22 We did, as I mentioned prior to the meeting, we 23

Page 21 prices are quite high, and issues, environmental regulations 1 continue to be a problem for some of the states, some of the 2 3 areas. 4 And then finally on April 30th, I was invited to a meeting organized by the Department of Health and Human Services 5 and the Department of Agriculture. 6 The purpose of the meeting was to explore the 7 possibility of moving various food related agencies into the 8 Department of Agriculture. It was a move that was apparently 9 requested that people start looking at by the governor. 10 11 So, the idea was to put these folks together, have a 12 meeting and discussion about what made sense and make a recommendation to the Governor's office. 13 14 There was no formal decision announced at that meeting, but it certainly appears to me, that from what I saw, they're 15 going to move anything that's based on Federal Department of 16 Agriculture food programs, they're going to move into the 17 18 Department of Agriculture, is what I think. There's a purchasing commodity food program through the 19 Department of Administration, it sounded to me like that would go 20 to the Department of Agriculture. State level. 21 And the two food, what they call food safety agencies, 22 which is the Health Division within the Department of Health and 23 Human Services, the rest of the Department of Health and Human 24 Services deals primarily with health. 25

1	It truly, medical care, those kind of things, or food
2	for people who are, you know, short nutritionally. So, it's
3	health care type oriented things.
4	The health division is actually inspecting restaurants,
5	food processors, other than dairy, to make sure they are safe and
6	complying with the law and all those things.
7	I think that, and it appears to me that the Dairy
8	Commission are going to get moved, all of them into the
9	Department of Agriculture. Based on what the conversation was,
10	and what was going around.
11	That recommendation is being worked up between Mike
12	Wilden, the head of the Department of Health and Human Services,
13	and Jim Barbee, the head of the Department of Agriculture.
14	They have to make a recommendation to the governor by
15	May 14th, and hopefully well get a firm decision what they're
16	going to do shortly thereafter.
17	One thing that did occur that kind of also indicates
18	we're going that direction is we had continuing input from the
19	Department of Business and Industry, where we are located now,
20	saying send over your fiscal work, send over your accounting
21	procedures, payables, receivables. We are going to take it all
22	over.
23	And we went down to a meeting, Walter went, and we said
24	to them, are you aware that there's this discussion going on, and
25	this may be premature, because there's no use going through

Page 23 shifting everything to you guys and turn around and shift it all 1 back. 2 And a couple days later, we got an e-mail message that 3 said given the possibility you are going to move, we're going to 4 5 hold on any shift. So, I think they probably talked to somebody. It looks 6 to me like they got the word that it was likely that we were 7 going to get moved to the Department of Agriculture and not be a 8 part of their consolidation. 9 So, from our standpoint, we would prefer that. 10 11 the lack of the consolidation, and we just haven't been real pleased with the speed, and, and what's the word I want. Speed 12 and accuracy, I quess, I hate to say it, of the work that has 13 14 been going on where we have had to go through B and I. So, I think we'll be happier hopefully going back to 15 being our own stand alone agency. 16 17 So, that's all I have on the staff report. 18 MR. GOEDERT: Can I ask a question? 19 MR. HETTRICK: Oh, please. 20 MR. GOEDERT: If we end up with agriculture, the Department of Agriculture, are they going, do we have any 21 indication that they are going to want to take over our 22 accounting and all of that new? 23 24 MR. HETTRICK: No. At this time, no. I mean Tom and I went over and visited with them and I mean I can't tell you what 25

Page 24 will happen in the future, and frankly that's probably our 1 biggest fear of going to the Department of Agriculture. 2 And I have expressed that to them, that it's the fear 3 4 of the unknown. You don't know what they are going to do down 5 the road. We know what we would like to do, what we think is the 6 best, but we don't know what they may decide they want to do. 7 But, as of this time, they said no. We don't have any 8 interest in taking over your stuff. You would be stand alone, 9 our board would not be over you in any way. They wouldn't, you 10 11 wouldn't have to report to our board, you wouldn't have any of 12 those things. You would just basically become a part of our 13 14 organizational chart. Which makes a lot of sense, because people 15 can't find us. If you go to the state website, you don't find us 16 unless you know to look for Business and Industry. And the 17 18 average person doesn't do that, looking for dairy. So, we think it would be a better fit in that regard. 19 20 So, I can't give you a direct absolute answer, but my feeling is at least initially, no, they're not going to deal with 21

2	The one thing that will happen has already occurred is
3	Human Resources work for both B and I and the Department of
4	Agriculture and have been taken over by the Department of
5	Administration, in their new Human Resources Division, or

7	And so it doesn't matter which of the two agencies
8	we're placed under, we will, Human Resources will go through the
9	state Department of Administration either way.

25	legislative action, I don't know. I can't answer that question.

1	So then, unless there are more questions or comments in
2	regard to that, then what we want to talk to you about,
3	Mr. Chairman, is to go back to agenda item number three.
4	Based on the reserves that we have at this time and the
5	revenues as we can project it, we feel it's appropriate to go
6	ahead and do another tax holiday.
7	We are proposing that we do that tax holiday for the
8	month of June, which is Dairy Month. We think that's an
9	appropriate thing to send our licensees something that says we
10	are pleased to give a tax holiday for dairy month.
11	And we are proposing to, Gayle did a lot of work, and
12	we have been able now to average the annual payments from every
13	licensee, rather than picking a single month, which we did the
14	first time, and so we've averaged them and done some other nice
15	detail work where we have been able to eliminate penalties, if
16	they had any, and late payments and some of those things.
17	So, it really worked out much more correctly, I guess.
18	It wasn't wrong the first time, but this is precise and much
19	nicer.
20	And we are recommending that we do 80 percent of one
21	month as a reduction this time.
22	So, if somebody had a bill for a hundred bucks, we're
23	going, their average monthly bill was a hundred dollars on their
24	assessment we're going to send them a credit for \$80.
25	We will actually mail out the credit, we'll specify

Page 27 they can take it on their June payment or after, until they use 1 it up. Because obviously some have fluctuation. And we 2 anticipate that that move will push us below the 400,000, which 3 is where we want to be. It will be about an \$88,000 reduction in 4 reserves that we will be giving back in June. 5 CHAIRMAN COOK: And everything is in place to be able 6 to initiate this on short notice? 7 MR. HETTRICK: Tomorrow morning. We're ready to go. 8 CHAIRMAN COOK: Is this something that requires a 9 10 motion? 11 MR. HETTRICK: It doesn't really require a vote. just need to have you folks know that that's what we intend to 12 do, and we wanted to inform you what we were doing and what we 13 14 think the impact will be. We like it, we like it going out in June, and we're 15 pleased to be able to give back to the people who pay the 16 assessments. 17 18 We wrote a letter that says we appreciate the fact that you do business in Nevada, and we are pleased to send you a 19 credit on your account. 20 21 CHAIRMAN COOK: Okay. Sounds good to me. MR. HETTRICK: That's all I --22 MR. CROWTHER: It's based on the average for June or 23 24 for the average overall? 25 MR. HETTRICK: Yes. It's based on the average monthly

Page 28 fee they pay, and we are giving them 80 percent of one month. 1 MR. CROWTHER: 2 Okay. MR. HETTRICK: So, if they pay a hundred a month, they 3 are going to get averaged for the 12 month year, then we are 4 going to give them an \$80 credit this time. 5 Some of the credits are quite large I saw in, we're 6 signing individual letters, and there are credits of \$15,000, 7 credits of five and \$6,000. There's some large credits. 8 9 MR. CROWTHER: Okay. Yeah, the reason I ask is because it seems like some of the, some businesses probably have seasonal 10 11 fluctuations. So, if we're saying 80 percent of, you know, a high, 12 one of their highest months, versus 80 percent of one of their 13 lowest months, that may make a difference to the company. 14 But, you're saying we're averaging for one year and 15 just taking that, not necessarily fixing any particular month. 16 17 MR. HETTRICK: That's correct. 18 MR. CROWTHER: Okay. 19 MR. HETTRICK: That's correct, and you're hitting it on the head. The first time we did it, we chose a month, and you're 20 correct. Some people had high months, some people had a low 21 month. And we just, at that time we didn't have the adjustment 22 that Gayle was able to make to our data base so we could average 23 24 them. 25 So, we went ahead and did it because we had

Page 29 instructions that we needed to reduce reserves. So we just chose 1 a month and did it, moved forward. 2 But this time we were able to do it in a lot more 3 sophisticated fashion and more even, fairer to everybody, and 4 we're pleased to be able to do it again. 5 MR. CROWTHER: Okay. 6 CHAIRMAN COOK: I suspect the industry will like that. 7 I would hope. So, we'd like to get some MR. HETTRICK: 8 publicity, but we are not getting much publicity out of it. 9 This is the third tax decrease since June 1 of 2011 10 11 that the tax commission will have done, and, you know -- I mean the Dairy Commission. I said tax commission. Dairy Commission 12 will have done, and we're quite pleased with that. I mean 13 14 obviously the reserves, we had reserves they were in place, we needed to reduce them. 15 But, we continue to save money and we are having to go 16 farther each time, you know, we're having to do more. 17 18 So, it's a good problem to have. 19 CHAIRMAN COOK: Yes. Very good. Thank you. 20 MR. HETTRICK: All right. Next is --21 MR. CROWTHER: I'm sorry. Does this require a vote or 22 not? 23 MR. HETTRICK: No, it doesn't. We have the ability to 24 do this. It doesn't require any formal action. 25 MR. CROWTHER: Okay.
