23	We received the completed regulation package back from		
24	LCB on February 8th, and then scheduled and noticed this hearing.		
25	The complete regulation package was posted to our

1	website and written comments were solicited.				
2	We have received no written comments. The purpose of				
3	this hearing is to solicit final comments from the public on the				
4	changes to the regulations.				
5	We will now open the floor to any questions or				
6	comments.				
7	And just to note, James, we have no public here.

9	MR. WRIGHT: Troy joined us. We have nobody else				
10	attending.				
11	MR. ORZECH: Okay.
