4	PURSUANT TO NOTICE, and on Thursday, the
5	15th day of June 2017, at the hour of 9:00 a.m. of
6	said day, at the offices of State of Nevada
7	Department of Agriculture, Sparks, Nevada, before
8	Janet Menges, a Certified Court Reporter, the
9	following proceedings were had:
10	
11	CHAIRMAN COOK: Let us convene the
12	June 15, 2017 meeting of the Nevada State Dairy
13	Commission, the final meeting I might add.
14	Mr. Hettrick, would you do the honors,
15	please.
16	MR. HETTRICK: Yes, sir, Mr. Chairman.
17	This is the time and place set for the
18	regularly scheduled meeting of the Nevada State Dairy
19	Commission for the month of June 2017. This meeting
20	has been scheduled and noticed in compliance with the
21	pertinent statutes, including the Open Meeting Law.
22	A copy of the agenda has been handed to
23	the court reporter with the request that it be a part
24	of the official transcript of these proceedings.
25	My name is Lynn Hettrick, the

administrator for Plant Industry Division of the 1 2 Department of Agriculture. 3 Present today are Mr. Christopher Cook, 4 chairman of the Commission; Mr. Troy G. Crowther, member of the Commission; Mr. John Collier, member of 5 the Commission. 6 7 Those who present statements or evidence 8 to the Commission during this meeting are requested to first be acknowledged by the chairman and to identify themselves for the record. 10 11 CHAIRMAN COOK: Would you proceed to the 12 first agenda item, please. 13 The first item on the MR. HETTRICK: 14 agenda, Mr. Chairman, is public comment and 15 discussion. 16 CHAIRMAN COOK: Okav. 17 Is there anybody here from the public at 18 this point who would like to make a comment or put 19 anything on the table for discussion keeping in mind 20 we will have another opportunity at the end of the 21 meeting? 22 Seeing none let's move on to number 2, 23 please. 24 MR. HETTRICK: Number 2 on the agenda, 25 Mr. Chairman, for possible action are approval of the

- 1 minutes of the May 18, 2017 Dairy Commission meeting,
- and we just need a motion to approve. I'm not aware
- of any corrections.
- 4 MS. INOUYE: No, there's none.
- 5 MR. HETTRICK: None, no corrections.
- So we just need a motion to approve the
- 7 minutes as presented.
- 8 COMMISSIONER CROWTHER: I will go ahead
- 9 and make the motion to approve the minutes of the
- 10 May 18th, 2017 Dairy Commission meeting.
- 11 COMMISSIONER COLLIER: Mr. Chairman, I
- 12 will second that motion.
- 13 CHAIRMAN COOK: Having a motion and a
- 14 second, no dissenting votes, the motion carries and
- 15 the minutes are adopted.
- MR. HETTRICK: Next, Mr. Chairman, on the
- agenda is the staff report, and I really don't have a
- 18 staff report this time. What I do have and you
- 19 should all have in your packet is the pricing, the
- 20 market administrator's report, if you have an
- interest in going through that again. I don't think
- 22 anything has changed significantly.
- We don't have anything going on, other
- than I will mention, and I don't know if all of you
- are aware of it or not, but a long time ago you

1 approved some money to do a study on a siding in 2 Churchill County, as you may recall, to have the potential that the dairymen in the Fallon area would 3 4 be able to buy commodities by railcar instead of 5 having to do it by truck, and that kind of seemed like it went away, but in fact I had a gentleman from 6 7 the Churchill Economic Development Commission come 8 over about a month ago and tell me that while the 9 study didn't generate the interest along came out of 10 the blue a company that wanted a siding and they had 11 it laying in their hand, the study, and handed it to 12 them and they have opened that siding and agreed to 13 allow the dairymen to use it. 14 So the money that you spent trying to 15 help develop that siding actually did help and they 16 are actually opening that siding and the dairymen 17 will be getting some ability to --18 CHAIRMAN COOK: Now, that's just 19 reopening an existing one that was shut down; right? 20 I'm not sure if it was MR. HETTRICK: 21 shut down or it was available and they had to add a 22 spur into it. I think they may have had to add a 23 spur into it and I think this company has agreed to do it, and I frankly don't remember all the detail 24 25 other than to let you know that in fact it actually

1 has opened or is opening and they will be able to use 2 it. 3 CHAIRMAN COOK: Did the Navy ever have 4 any interest in jumping in on that and taking 5 advantage of --6 MR. HETTRICK: Not that I'm aware of. 7 What I got from the Churchill guy was simply that he 8 wanted to let us know that it helped and they 9 appreciated it, because when they got interest they 10 had a study that said yeah, here's one, this works, 11 and they handed it to them and they decided to move 12 forward. 13 CHAIRMAN COOK: Well, that's great. 14 MR. HETTRICK: So it worked out good. 15 So that's all I have. 16 CHAIRMAN COOK: Have you seen anything or 17 heard anything about whether the flooding out in 18 Mason Valley is impacting the --19 MR. HETTRICK: Have not. 20 CHAIRMAN COOK: -- alfalfa crop? 21 MR. HETTRICK: I haven't heard anything 22 that it's --23 CHAIRMAN COOK: If there's flooding. 24 MR. HETTRICK: Yeah, if there is. I'm 25 not aware of any in Mason Valley and the -- and

1 you're probably all aware that they dug a giant 15 2 foot deep trench clear from near the Lahontan all the way out to Stillwater, miles and miles, to drain 3 4 water to prevent flooding in the Fallon area and that 5 apparently is working well, so but I haven't heard anything about flooding, no, not aware of any. 6 They 7 were well aware it was coming and they were doing a 8 lot of work clearing the river and everything, I 9 know. 10 CHAIRMAN COOK: Yeah. 11 Well, my question is really I know a lot 12 of that water gets diverted out into some of those 13 southern fields in the southern part of the valley 14 and I was just wondering if it was --MR. HETTRICK: 15 I heard there was some 16 water in the fields, but I don't think it was 17 considered to be a major issue. 18 They typically have hay CHAIRMAN COOK: 19 down and in the process of baling, so okay. 20 MR. HETTRICK: So that's all I have on 21 staff report, unless anybody has questions? 22 CHAIRMAN COOK: The starling program? 23 MR. HETTRICK: Up and running. Avitrol was doing a webinar, actually I think it's today. 24 Ι don't know who signed up or who may have signed up 25

for it. 1 2. Several of our dairymen, as you know, got 3 their own permits to -- and training through the 4 department to apply their own Avitrol and that's 5 worked out to be pretty effective. They like that. 6 So while we thought it wasn't going to be 7 as effective as the federally licensed material, it 8 seems to have been a pretty effective product for 9 So I think we'll see that continue. We'll see them. 10 how it goes. 11 CHAIRMAN COOK: The Department is going 12 to continue to --13 MR. HETTRICK: As far as I know we will 14 continue. I mean we have the revenue. They generate 15 I don't see any reason why we won't the revenue. 16 continue that program, and it's been in budget now, 17 it's been there for 4 or 5 years, close to it, 18 between the federal and the -- so it's been there a 19 while so I don't see any reason why it won't go on as 20 part of the budget. We'll see how that goes, but no, 21 I expect it to continue. 22 CHAIRMAN COOK: Okav. 23 All right. MR. HETTRICK: 24 CHAIRMAN COOK: Any other questions for 25 Mr. Hettrick?

1 COMMISSIONER CROWTHER: Where do we stand 2 on getting another cow down south? 3 MR. HETTRICK: It's in the budget, paid. 4 It passed through the legislature, the trailer and 5 the cow are coming, and in addition to that they gave 6 us two part-time Manpower employees to take them to 7 the schools. 8 COMMISSIONER CROWTHER: To drag them 9 around. 10 To actually take them MR. HETTRICK: 11 around to the schools or wherever else. In fact, 12 Saturday I'm taking Moolissa to the Rocky Mountain 13 Elk Foundation kids day in Carson City, and you can't 14 believe the calls we get. The day after that she'll 15 be at the -- at an event in the Livestock Events 16 I can't think now what it is, but she'll be 17 at an event in the Livestock Events Center that we 18 did last year. 19 We have her out at least a day or two a 20 week, if we have people to haul her. So with the new 21 temp coming for each, we'll get one north and one 22 south, a temporary person to take them, we'll be able 23 to hopefully have them out in the schools or in the 24 community even more frequently. 25 Of course she has made it to the

- 1 legislature the last, I think, three years in a row
- and we've got pictures of the Governor and everybody
- 3 else milking Moolissa, all the legislators. It's a
- 4 huge draw and so it's been a very popular thing and
- 5 we're glad to see it going down in the south. We
- 6 should see some more activity down there.
- 7 Yeah, so that's all done, it was in the
- 8 budget and it was all passed.
- 9 CHAIRMAN COOK: See, Dave, we take care
- of you down there.
- MR. COON: Thank you.
- MR. HETTRICK: Are we clear down there to
- 13 you guys? Can you hear us all right?
- MR. COON: Yes.
- MR. HETTRICK: Because everything you say
- 16 back to us is very broken up. So just to let you
- 17 know if we kind of look at you with a funny
- 18 expression it's because we're trying to figure out
- 19 what you said.
- MR. COON: Well, I was responding to the
- 21 Chairman's comments that they have always taken care
- of us down here in the industry and my response was
- you always have, thank you.
- MR. HETTRICK: Okay, all right.
- 25 CHAIRMAN COOK: Okay.

1	
1	MR. HETTRICK: Ready to move on?
2	CHAIRMAN COOK: Let's move on.
3	MR. HETTRICK: Number 4, status of AB 33,
4	which abolishes the Dairy Commission, amongst others,
5	and transfers the duties. That obviously passed
6	through the legislature, and again I would just
7	comment on that to let you know that that had nothing
8	to do, as you all know, with the work that was done
9	by the Dairy Commission or anything else.
10	It's a situation where this has evolved
11	to a point that these dairymen don't need protection
12	on pricing and they don't need, you know, anything
13	that we could really give them, and the licensing has
14	become an administrative function. So it's just
15	something where you guys did too good of a job and
16	you worked yourself out of one. So that's the way it
17	goes.
18	It's a good thing for the public. It's
19	very impressive, I will say, at the last board
20	meeting we brought it up and the people who were
21	there, we said the Dairy Commission worked itself out
22	of a job, gave rebates, cut taxes, eliminated a lot
23	of overhead and the paperwork and so on over the last
24	few years and worked themselves out of a job, and
25	everybody says wow, that's cool, a government agency

1 that actually gives back money and works itself out 2 of a job, that doesn't happen very much. 3 So in many ways I'm sad to see it go, but I think you guys ought to be proud of the work you 4 5 did, so good job. So that's where we are on 33. 6 On number 5, Mr. Chairman, if you're 7 ready for that, consideration of any other matters 8 relating to the dairy industry. CHAIRMAN COOK: Well, I will take this 9 10 opportunity, exercising my prerogative as the 11 Chairman, my rapidly waning prerogative as the 12 Chairman, to acknowledge the contribution that you 13 made, and I've said it many times in the past that 14 one of the most fortuitous decisions that we made as 15 a Commission was to hire you as the executive 16 director back in, when was that, 2009. 17 MR. HETTRICK: Ten. 18 CHAIRMAN COOK: 2010. 19 I would also like to acknowledge some of 20 the people that have served as Commissioners in the Randy Tollman was the chairman when I came on. 21 past. 22 Tom Mora, who became the chairman after Randy left 23 the state, and then Tom subsequently left and I Obviously Troy and John Collier and 24 became Chairman. 25 Bob Fletcher, for the brief period of time that he

- 1 served, and the list of people that worked for the
- 2 Commission, employees, and I'm sure I'm going to
- 3 forget some of them, but certain people like Anna
- 4 Vickrey and Mark French and Tom Worsac and Gail,
- 5 whose last name escapes me at the moment.
- 6 MR. HETTRICK: Wilmouth.
- 7 CHAIRMAN COOK: Wilmouth, Kathy Easly,
- 8 they all made serving in this role very pleasurable
- 9 and interesting and enlightening and it's been a fun,
- 10 for me, 13 years.
- I guess ultimately, probably we ought to
- 12 acknowledge Governor Guinn, former now deceased
- 13 Governor Guinn for his appointment or appointing me
- in the first place back in 2014, and then Governor
- 15 Guinn and Governor Sandoval for renewing those
- 16 appointments.
- So for me personally it's been a very
- interesting, educational, eye-opening experience and
- 19 I've met some wonderful people and it's been a fun
- 20 13 years.
- MR. HETTRICK: Okay.
- 22 COMMISSIONER CROWTHER: I echo what you
- 23 said. I especially appreciate the folks in the
- industry. We've had some growth. We've seen
- 25 positive things happen in the state over that time.

I think I've been on just maybe three years shorter 1 than Chairman Cook and, you know, we've seen I think 2 lots of growth, lots of positive things in the 3 4 industry, and I look forward to seeing that increase 5 and move forward under the current leadership and, 6 you know, what's going to be taking the place, I 7 quess, of the Dairy Commission, and I do appreciate 8 serving with all those that Chairman Cook has 9 mentioned and I've learned a lot. 10 So thank you. 11 COMMISSIONER COLLIER: Likewise, I'm very 12 appreciative of the opportunity to have to be able to 13 become acquainted with this commission and the Dairy 14 Commission and the Department of Agriculture, and 15 Lynn, you've done a sterling job during my short 16 tenure, and Chris and Troy, it's been a pleasure to 17 get to know you gentlemen and be associated with you 18 in this endeavor, and I think we've accomplished a 19 few things in the course of it, and thanks to our new 20 staff members and everybody that has been involved 21 with our group, because we've, I think, prospered and 22 we've made a contribution and it's good to know that we've worked ourselves out of a job and we've saved 23 24 the state some money. So that's good. 25

So thank you all for the opportunity to

1 be a part of it. 2. CHAIRMAN COOK: Not to be left out in any 3 of these accolades, too, is the industry people that 4 we've had to work with, Dave being one of the 5 favorites, I think. We've always appreciated your 6 support, Dave, and wish you luck and good fortune in 7 the future. 8 MR. COON: Thank you, Mr. Chairman. 9 At some point I do have some -- if you 10 will let me know when that should be. 11 All right. MR. HETTRICK: 12 I think what we will do is, with your 13 permission, Mr. Chairman, we will move to number 6 14 and then what the Board of Agriculture, when we presented the results of AB 33 passed resolutions and 15 16 I would like to read the resolutions into the record. 17 Actually I will read one, because they are 18 essentially identical, but they have passed 19 resolutions and I think then, Dave, it would be 20 appropriate for whatever comments you would like to 21 make. 22 So there's one of these for each of you, 23 and again I'm going to read it into the record and 24 then we'll give the actual copies to the court 25 reporter so they can get submitted.

1	Board of Agriculture.
2	WHEREAS, on August 1st, 2004 Christopher
3	Cook was appointed to the Nevada Dairy Commission by
4	Governor Kenny Guinn; and
5	WHEREAS, Christopher Cook served as the
6	Chairman of the Dairy Commission; and
7	WHEREAS, during his tenure the Dairy
8	Commission rebated taxes on three occasions and
9	streamlined the day-to-day operations of the agency;
10	and
11	WHEREAS, Christopher Cook facilitated the
12	merger of the Dairy Commission into the Nevada
13	Department of Agriculture in 2013; and
14	WHEREAS, because of the subsequent cost
15	savings, the Commission eliminated all tax on fluid
16	milk sold in Nevada, and
17	WHEREAS, the Commission funded the
18	purchase of Moolissa, the mechanical milking cow, as
19	an aid to teach children about dairying and the
20	nutritional value of dairy products; and
21	WHEREAS, the Commission funded a rail
22	siding study and starling control program which have
23	enhanced the economic viability of Nevada's dairy
24	industry; and
25	WHEREAS, by early 2017, the dairy

industry in Nevada had evolved to the point that a 1 formal Dairy Commission was no longer necessary and 2 the Commissioners endorsed Governor Sandoval's 3 4 proposal to have the Legislature eliminate the Dairy 5 Commission and make the daily operations an administrative function within the Department of 6 7 Agriculture; now, therefore, be it 8 RESOLVED by the State of Nevada Board of 9 Agriculture, that the members of the Board of 10 Agriculture express sincere gratitude to Commissioner 11 Christopher Cook for his dedication and public 12 service to the State of Nevada; and be it further. 13 RESOLVED, that the Director of the Nevada 14 Department of Agriculture prepare and transmit a copy of this resolution to former Chairman and 15 16 Commissioner Christopher Cook. 17 Adopted by the Board of Agriculture, 18 signed by Paul Anderson, Chairman, and with that we've got actual copies, framed copies for each of 19 20 you. 21 Jerri, do you want to do them? 22 MS. CONRAD: That's okay. 23 I can hand them out. MR. HETTRICK: 24 MS. CONRAD: That's fine. 25 Well, here is Christopher Cook, and John.

1	COMMISSIONER COLLIER: Thank you, ma'am.
2	MS. CONRAD: And Troy.
3	COMMISSIONER CROWTHER: Thank you.
4	MS. CONRAD: And although on a regular
5	basis I haven't had personally much interaction with
6	the Dairy Commission, I'm here, though, to thank you
7	on behalf of the Nevada Department of Agriculture and
8	Director Barbee.
9	Most of my involvement with the
10	Commission has been through Lynn and I want to say we
11	appreciate your dedication to the industry and I
12	personally am my background is in outreach and
13	education. So everything you do to educate folks
14	about the value of the dairy industry as well as the
15	nutrition that dairy brings to a diet is really close
16	to my heart. The paper materials, the Moolissa, the
17	classroom visits, I think that we're better off from
18	an agriculture standpoint because of all you guys
19	have done.
20	Thank you so much.
21	CHAIRMAN COOK: Thank you.
22	COMMISSIONER CROWTHER: Thank you.
23	COMMISSIONER COLLIER: Thank you.
24	CHAIRMAN COOK: I appreciate that.
25	MR. HETTRICK: All right, Dave, if you

would like to make some comments now is a good time. 1 2. I hope you can hear me all MR. COON: 3 right. Can you hear me? 4 MR. HETTRICK: It's a little fuzzy, but 5 we can hear you, go ahead. 6 COMMISSIONER CROWTHER: Our reporter 7 might have a challenge. 8 MR. BELCOURT: Do you want him to call in 9 on the phone. 10 MR. HETTRICK: Do you have a phone there 11 and do you want to call in on the phone, if you want 12 to call. It might be better. What is your phone 13 number there? 14 COMMISSIONER CROWTHER: Dave, if you want 15 to call my cell phone I will put it on speaker. 16 MR. COON: Would that be okay? 17 That's fine. MR. HETTRICK: 18 COMMISSIONER CROWTHER: That might be 19 easier, either way. 20 MR. COON: What was that, Troy? 21 COMMISSIONER CROWTHER: (702) 401-4024. 22 MR. COON: You can here me okay? 23 COMMISSIONER CROWTHER: Yeah we need to 24 turn down the TV, though. 25 MR. HETTRICK: Do you want to try it?

1	COMMISSIONER CROWTHER: Okay.
2	MR. COON: Can you hear me okay now?
3	COMMISSIONER CROWTHER: Yeah, that's much
4	better.
5	MR. COON: I'm glad you can.
6	You know has given us the opportunity
7	to kind of reflect. We go back a long way in the
8	State of Nevada and with the Dairy Commission. We've
9	had a wonderful relationship through the years,
10	through the with the Commission.
11	MR. HETTRICK: Hang on, Dave. We're
12	sorry. Why don't you put it right in front of her.
13	We can hear okay and we need to make sure Try one
14	more time, Dave, because it's been very difficult for
15	her to hear well enough to record.
16	MR. COON: Okay.
17	MR. HETTRICK: Try to go slow.
18	MR. COON: Okay.
19	Sorry for all the trouble, but I am
20	grateful for the opportunity to express some
21	heartfelt feelings toward the Commission and the
22	State of Nevada.
23	We have dealt with the Dairy Commission
24	for many decades. We are very proud of the dairy
25	industry within the state, proud to be a member of it

- 1 and thankful for the oversight, the regulation that
- 2 the Commission has provided to ensure safe and
- 3 healthy products for the consumers of the state and
- 4 also to oversee the marketing strategies of the
- 5 dairies to make sure that everyone is playing by the
- 6 same rules, abiding by the same laws and so forth,
- 7 and in those years you can't help but strike up
- 8 personal associations and even though those are built
- 9 upon respect and -- for the agency and for the
- 10 relationship, the interaction, as I said you build up
- 11 personal associations with people that you have to be
- 12 grateful for through the years.
- So to you, Mr. Chairman, Chris, John,
- 14 Troy, you certainly are representative of all those
- that served before and we have had the pleasure of
- 16 working with.
- Lynn, thank you for your contribution
- 18 and -- is here, but we just think back on all those
- 19 people that have helped the industry and have helped
- 20 a business such as ours and given us the opportunity
- 21 to compete and we are grateful and we want you to
- 22 know.
- So thank you very much and our very best
- 24 to you and your families.
- 25 CHAIRMAN COOK: Thank you, sir. Same to

1 you. 2. COMMISSIONER CROWTHER: Thank you, Dave. 3 COMMISSIONER COLLIER: Thank you, Dave. 4 MR. COON: Thank you. 5 We're going to let you turn that -- Can 6 you hear us all right? 7 All right, just wanted to make sure you 8 could hear us. 9 Unless there's anything else I've got 10 copies to present to court reporter for our -- of the 11 resolutions and there's going to be cake and coffee 12 and milk in the break room next door, and also all of 13 you are welcome here to stay for lunch, if you would 14 like to because of the barbecue that we have in 15 courtyard later today at 11:30. 16 So unless you have more, Mr. Chairman, 17 that's all I have for the meeting. I do need to say 18 number 6, public comment and discussion if there is 19 any more just for the record. 20 CHAIRMAN COOK: And I think we've covered 21 that. Anybody else want to throw anything out on the 22 table? Your last chance ever, end of an era. 23 MR. HETTRICK: Be proud. All these 24 minutes are going to go in the archives. They will 25 be there forever.

1 Nobody will ever read CHAIRMAN COOK: 2 them, but --3 MR. HETTRICK: You would be surprised. Ι think you might be surprised. We went back multiple 4 5 times and looked at the records when I got involved. So if there's nothing 6 CHAIRMAN COOK: 7 else for the good of the industry, Dennis, do you 8 want to say anything? 9 Well, I've been the silent MR. BELCOURT: 10 one in all these meetings for the most part because 11 they have been conducted so well. I appreciate it. 12 I always enjoy coming here to the Dairy Commission 13 meetings and I think there are a lot of -- you've had 14 attorneys who had much more longevity than I, but 15 I've been coming these for about four years. So 16 thank you very much for having me. 17 Thank you for being our CHAIRMAN COOK: 18 regular guy, our go to guy for -- I guess probably 19 naming names from the past, it would be appropriate 20 to acknowledge Warren Goedert and the contributions 21 he made for many years as the staff counsel. He was 22 an interesting guy to make the trips back and forth 23 to Las Vegas with, but we made those trips, and of 24 course Jerry Silver, who was court reporter who was 25 permanently assigned to us for many, many years as

1	well.
2	So I'm sure I've overlooked somebody and
3	I want the record to reflect that it's not
4	intentional. It's just the encroaching years that
5	are gumming up the brain synapsis, but at any rate
6	it's been a fun ride, it's been interesting, and I
7	have enjoyed it and appreciate all the people that I
8	have met and friends I have made and the knowledge
9	that I have gained about the industry and hope the
10	industry thrives and grows and gets even bigger in
11	the State of Nevada and the Department of Agriculture
12	runs with it and we can take all those dairymen away
13	from California and move then over here.

15	the table? Seeing nothing for the last time the
16	gavel comes down on the Nevada State Dairy
17	Commission.
