1 SPARKS, NEVADA; THURSDAY, JUNE 18, 2015; 1:00 P.M. 2 -000-3 4 CHAIRMAN COOK: Let us convene the June 5 meeting of the Nevada State Dairy Commission. Mr. Hettrick, could you open the proceedings, please. 6 7 MR. HETTRICK: I would. This is the 8 regularly scheduled meeting of the Nevada State Dairy 9 Commission, and --10 MS. EASLY: Did I not put it in there? 11 MR. HETTRICK: No, you didn't. But it's 12 fine, I'll take it. 13 MS. EASLY: Okay. I can go print it real 14 quick. 15 MR. HETTRICK: No. We're all right. I'11 16 do it in pieces, piecemeal as I remember it, but we'll 17 get it. 18 Those who present evidence are asked to 19 please first be recognized by the chairman and identify 20 themselves for the record. 21 My name is Lynn Hettrick, deputy director, 22 Department of Agriculture. Present today is Christopher 23 Cook, chairman of the commission; Troy G. Crowther, 24 member of the commission; John Collier, member of the 25 commission.

1 This meeting has been scheduled and noticed 2. in compliance with pertinent statutes, including the open meeting law. A copy of the agenda has been handed 3 4 to the court reporter, with the request that it be a 5 part of the official transcript of these proceedings. That covered it all, just not in the right 6 7 order. 8 CHAIRMAN COOK: Okay. Hit all the high 9 points. 10 MR. HETTRICK: Got all the ones we have to 11 do for the record. 12 CHAIRMAN COOK: Okay. Thank you, Mr. 13 Would you proceed to the first agenda item, 14 please. 15 MR. HETTRICK: First item on the agenda, Mr. 16 Chairman, is public comment. 17 CHAIRMAN COOK: Okay. And we are blessed 18 with one member of the public. Would you care to make a 19 comment, or would you like to withhold and make it later 20 in the meeting? 21 MR. RECK: Withhold until later. 22 CHAIRMAN COOK: Okay. 23 MR. RECK: If necessary. 24 CHAIRMAN COOK: Thank you. Proceed to the 25 next item.

- 13 CHAIRMAN COOK: And is there anyone
- 14 representing this applicant present? It does not appear
- 15 so.
- Is there anything else that staff would care
- 17 to add to this?
- 18 MR. HETTRICK: Unless Kathy has something, I
- 19 have nothing. It looks pretty straightforward.
- MS. EASLY: I didn't talk to them.
- 21 CHAIRMAN COOK: A new retailer in Vegas,
- 22 or --
- MR. HETTRICK: Yeah. Save-A-Lot, I think,
- is probably a discount store, if I had to guess.
- 25 Discount market. Looks like they're carrying a pretty

full line of products, based on the sheet they send us. 1 2. MS. EASLY: They're under SuperValu, because that's where their checks come from. 3 4 CHAIRMAN COOK: Oh, okay. 5 MS. EASLY: So I would, I would agree with Mr. Hettrick, that they're just another little --6 7 CHAIRMAN COOK: Maybe an off-price outlet 8 type? 9 MS. EASLY: Uh-huh. 10 CHAIRMAN COOK: Okay. All right. Well, I 11 have no further questions. Troy, John, do you have any 12 questions you would care to ask? Comments? 13 COMMISSIONER COLLIER: I have none. 14 COMMISSIONER CROWTHER: No questions. 15 CHAIRMAN COOK: Okay. Seeing none, any 16 questions or comments from the public? Or the staff? 17 Seeing none, I will entertain a motion. 18 COMMISSIONER COLLIER: Mr. Chairman, I move 19 that we accept the peddler-distributor application for 20 Save-A-Lot, located in Rancho Cucamonga, California. 21 They seek to, a license to distribute a full line of 22 dairy products in the Southern Nevada Marketing Area. 23 COMMISSIONER CROWTHER: Second. 24 CHAIRMAN COOK: A motion and a second and no 25 dissenting votes, the motion carries and the license is

1 granted. 2. MR. HETTRICK: Next on the agenda, Mr. Chairman, is another processing-distributor license from 3 4 Gelatology -- Gelatology, I think they say "Gelato" --5 in Las Vegas, Nevada. The applicant seeks a license to distribute 6 7 ice cream, sherbet, novelties, frozen yogurt, in the 8 Southern Nevada Marketing Area. The applicant's prices and costs have been reviewed by the Dairy Commission 9 10 staff and are in compliance with the agency's laws and 11 regulations. The applicant will be responsible for the 12 assessments. 13 CHAIRMAN COOK: Okay. Anything that needs 14 to be added to this? 15 MS. EASLY: She, the gal that applied for this license has worked for another Gelato company that 16 17 has a license with us, but she would not give me their 18 name. 19 MR. HETTRICK: Okay. 20 MS. EASLY: And she's branching out on her 21 own. 22 CHAIRMAN COOK: Oh. 23 MS. EASLY: And that's why she's applying 24 for this license. 25 CHAIRMAN COOK: Okay.

1 COMMISSIONER CROWTHER: It seems that in the past when they've brought in the ice cream and novelties 2 and that, we've had specific brand names on these 3 4 applications. Is that required? 5 MR. HETTRICK: If they, if they market it in a package with a brand name on it, it would have to have 6 7 the appropriate labeling, but this appears to be a shop 8 that's going to sell it in a cone or a cup. So it lists 9 the, the brand name as Gelatology, and the manufacturer 10 is Gelatology, and she lists her name as Gelatology as a 11 corporate name. So --12 CHAIRMAN COOK: Does she make her own 13 product? 14 MR. HETTRICK: Yeah, she's making her own 15 She probably buys a mix or something from product. 16 somebody, but she's making her own product. So, I mean, 17 there's no label requirement if you don't sell it in a 18 package. If you sell it for consumption, you don't have 19 to have it labeled. 20 COMMISSIONER CROWTHER: Okay. No other questions. 21 22 CHAIRMAN COOK: Questions, John? 23 COMMISSIONER COLLIER: I have none. 24 CHAIRMAN COOK: Questions or comments from 25 staff? Public? None. I'll entertain a motion.

1 COMMISSIONER CROWTHER: Mr. Chairman, I will 2. make a motion that we approve the processing-distributor 3 license application by Gelatology, LLC, Las Vegas, Nevada, to distribute ice cream, sherbet, novelties, and 4 5 frozen yogurt in the Southern Nevada Marketing Area. 6 CHAIRMAN COOK: Okay. I hear a motion. Is 7 there a second? 8 COMMISSIONER COLLIER: I'll second that. 9 CHAIRMAN COOK: Having a motion and second 10 and no dissenting votes, the motion carries, the license 11 is granted. 12 MR. EASLY: I thought the same thing: Where 9 is the other one? 10 CHAIRMAN COOK: Are you redesigning the 11 packaging? 12 MR. RECK: Packaging is redesigned. 13 actually in the marketplace as we speak. Items like, 14 ancillary items like half and half, buttermilk, whip 15 cream, those kind of things, are kind of coming in 16 phases as we go through. 17 CHAIRMAN COOK: Yeah, I've seen the labels. 18 MR. RECK: White milk, gallons, half 19 gallons, quarts, they've been out since April 1st, I 20 think. I think, yeah, April 1st. We, I mean, we talked 21 to Anna about that. 22 CHAIRMAN COOK: And that's across the entire 23 Dean Foods --24 It's from, yeah, from east coast MR. RECK: 25 And it allows us to do a lot of things to west coast.

- 1 with the company, tie in with, cross merchandise with,
- 2 like, General Mills --
- 3 CHAIRMAN COOK: Yeah.
- 4 MR. RECK: -- or whatever, other companies.
- 5 And we're hoping to just naturally grow the dairy
- 6 business by doing this, versus this downward trend that
- 7 we've been having for the last couple of years. We
- 8 think it will help a lot.
- 9 CHAIRMAN COOK: Well, we're trying to help
- 10 do everything we can do to turn that around. Within the
- 11 limits of our constraints. Drink more milk.
- MR. RECK: Drink more milk. Yeah, we've
- 13 been doing that too, but it's very difficult.
- 14 CHAIRMAN COOK: Okay. Well --
- 15 COMMISSIONER CROWTHER: I have a question.
- 16 You mentioned that you, you've got something in the
- 17 Southern Nevada Marketing Area as well. Will that be
- under Model Dairy, or is that going to be under Meadow
- 19 Gold?
- MR. RECK: That, that will be under the

- 24 COMMISSIONER CROWTHER: Okay. So that would

1 MR. RECK: More paperwork. 2. COMMISSIONER CROWTHER: Okay. No other questions. 3 4 MR. RECK: I kind of feel bad and apologize 5 that we didn't have it for this one. CHAIRMAN COOK: It's summertime. Stuff 6 7 happens. 8 MR. RECK: Stuff happens. 9 CHAIRMAN COOK: John, any questions? 10 COMMISSIONER COLLIER: I have none that 11 pertain to this. I have questions that I'll speak to 12 you off the record about. 13 MR. RECK: Okay. 14 COMMISSIONER COLLIER: They totally don't 15 have anything to do with this. CHAIRMAN COOK: Questions or comments from 16 17 staff? second that motion. 1 2. CHAIRMAN COOK: Having a motion and a second and no dissenting votes, the motion carries and the 3 4 license amendment is granted. Thank you, gentlemen. 5 Proceed to the next. MR. HETTRICK: The next item on the agenda, 6 7 Mr. Chairman, for action is approval of the minutes from 8 the May 21st meeting of the Dairy Commission. There are minor changes, which have been submitted to the court 9 reporter. Other than that, we just need a motion and a 10 11 second to approve the minutes as amended. 12 THE WITNESS: Mr. Chairman, I'll make a 13 motion that we approve the minutes as amended from our 14 last meeting. 15 COMMISSIONER CROWTHER: Second. With the 16 corrections. 17 COMMISSIONER COLLIER: With the following 18 corrections. 19 CHAIRMAN COOK: For the May meeting. 20 MR. HETTRICK: Yeah. 21 CHAIRMAN COOK: Okay. Motion and a second, 22 no dissenting votes. The motion carries and the minutes 23 are adopted, as noted. 24 MR. HETTRICK: Next on the agenda, Mr. 25 Chairman, item number five for possible action is a

- 1 discussion of the possible purchase of a second trailer
- 2 and the purchase of a second Moolisa. You recall that
- 3 this came up last time and it was not agendized, so we,
- 4 we kind of tabled the discussion until we could agendize
- 5 it and go from there.
- I did have the opportunity to discuss this
- 7 with the director of the Department of Agriculture, and
- 8 he's very supportive and thinks it would be a good idea.
- 9 He does think we, we need to wait to do the actual
- 10 purchase, probably until January. And that's because of
- 11 when budgets come in and we're allowed to spend money
- 12 and put through the purchase orders and on and on. So,
- but other than that, he didn't seem to have a problem
- 14 with it.
- 15 We're hopeful that not only would Erica --
- 16 when Erica was hired, Erica Ryan, who is the
- 17 environmental health specialist in Southern Nevada, she
- 18 actually signed on with the intent, in her job
- 19 description, that she was going to do some outreach to
- 20 the schools and the like. And we have not had the
- 21 ability to do that because the wearable cow has become
- 22 kind of a safety risk and we've backed away from using
- 23 it. So she's not had the opportunity to do that. I
- think she'd actually enjoy doing this and taking the cow
- 25 around.

1 And if she had a decent trailer, she could 2. do it by herself, because inside the trailer, you just open the doors and the kids can walk in. There's a ramp 3 4 in and a door out, and you could run kids through that, 5 take it to schools, and could really do a decent job 6 with one person. 7 So it would be a good thing to have, good 8 thing to do, and it's part of what we hope to do up here So that's kind of where we are on the nuts and 9 as well. 10 bolts of it. 11 CHAIRMAN COOK: Do you have to go through 12 any kind of approval with --13 MR. HETTRICK: Yeah. We have to go through 14 fiscal, as we always do, and do all of the budget work 15 for that. It will have to be a work program. It is not 16 in our existing budget. So it will -- and that's part 17 of why it will take longer, it will take a work program 18 and it will take IFC approval, and it will, you know, 19 then we can process from there. 20 CHAIRMAN COOK: We're good to go on the 21 trailer for --22 This trailer, yes, has to MR. HETTRICK: 23 wait until July 1, because under the budget rules we 24 can't expend money, we can't obligate money, we can't 25 even send them a purchase order. We have to sit and

wait until July 1 before we can do anything, under the 1 2 state budget rules. 3 CHAIRMAN COOK: But it's all --4 MR. HETTRICK: The trailer is ready to go. 5 CHAIRMAN COOK: -- approved? It's good. It's in the budget --6 MR. HETTRICK: 7 CHAIRMAN COOK: Budgeted. 8 MR. HETTRICK: -- and that's ready to go. 9 We've got a bid, we've got -- everything's done. We're 10 ready to order the trailer. The guy has given us a firm 11 bid, gave us a heck of a price. 12 What we're, the trailers are actually 13 manufactured in Phoenix, Arizona, and what we are 14 talking about doing is sending a staff member from the 15 Las Vegas NDA office down to Phoenix on a day trip, hook 16 on the trailer, bring it back to Las Vegas. And then 17 we'll send somebody down from here, or we can leave --18 that will be the first trailer. We'll bring the first trailer, then, up to here. And that will become 19 20 Moolisa's home, other than when she's in the lobby. And 21 then as soon as we can order a second trailer, we'll 22 just have them go pick it up and pull it into Vegas, and 23 order the cow shipped direct to Vegas. 24 COMMISSIONER COLLIER: Will the trailer that 25 is located here in Reno, Nevada, will it be the same

type of what you just described, where the people can 1 2 walk through it and --3 MR. HETTRICK: Yes. 4 COMMISSIONER COLLIER: -- actually milk the 5 cow and all that type of thing? 6 MR. HETTRICK: Yes. Yes. I actually have 7 photos of it. If you want me to run and get it, it 8 takes just a minute. But whether you want to wait that 9 long, it's up to you folks. 10 But the trailer is really nice. It's got a 11 beautiful rubber mat floor, rubber mat -- it's a 12 drop-down walk-in door with rubber matting on all of 13 that for safety, nonskid. Nice man door on one side, in 14 the front, and walk-in ramp at the back. Fully wired 15 for lights, light switch, LED lighting throughout. Nice 16 looking aluminum wheels. I mean, it looks spiffy. 17 really looks nice. 18 And then the intent is, after we get the 19 trailer and move on down the road a little ways, we want 20 to skin it with Dairy Commission, NDA, agriculture, or 21 anything to promote ag in general. Because it will get 22 multi-use here. But -- as we multi-used other equipment 23 and other people's equipment to move the cow and all the 24 So it will kind of be a joint use purchase, but rest. 25 it will come through the Dairy Commission to get it,

because of the funding that's available there. 1 2. COMMISSIONER COLLIER: Who's going to be responsible for taking it around here in the north? Are 3 4 you going to do that, or is staff going --5 MR. HETTRICK: I do it, I do it frequently. And I like to do it. 6 7 COMMISSIONER COLLIER: Or is Anna going to 8 do that? 9 MR. HETTRICK: Everybody kind of takes 10 And when we go, it depends on the event we go 11 to, we get volunteers. Generally when we go to the, 12 like the Sesquicentennial, that was down in a Carson, we 13 took the cow down there, and we also took along displays 14 about NDA, about weeds and about bugs and about, you 15 Everything we do, we took it down there. name it. So a 16 staff person from each one of those divisions came down 17 and, and we were all there, manned it, and where you 18 have people can answer questions about everything and talk about everything. Just promote ag in general is 19 20 what we go and do. 21 So this will work out really slick when we 22 go to the World Ag Expo in Tulare, because we'll 23 basically pull in, park the trailer at an angle. 24 just booked our booth again for next year. It's a, it's 25 a 20 by 40 booth. We'll be able to back this 24-foot

- 1 trailer in at an angle. We'll put the cow out in front,
- 2 it's under a roof, roofed area, so the cow can actually
- 3 come out. We'll use the interior of the trailer for
- 4 displays, walk through, give people something more to
- 5 do. And then we'll have some outside displays on the
- 6 tables and a little display tent as well.
- 7 So it will look real slick. And it will
- 8 have all the skin on it. All the signs are there. We
- 9 don't have to go down and put up signs on anything else.
- 10 CHAIRMAN COOK: Are you going to skin it to
- 11 make it look like a Holstein?
- MR. HETTRICK: Black and white? I quess to
- 13 some degree, yeah. We're going to have to figure out
- 14 how we make it look like a goat. We have some goat
- 15 dairies too. So --
- MR. RECK: Got any egg farms?
- 17 MR. HETTRICK: Yeah. So we're excited about
- 18 it. I mean, if you guys decide you want to approve the
- 19 purchase, then we'll pass that forward and start, start
- 20 the work-up. That's up to you.
- MR. COLLIER: Do you need a formal motion
- 22 about the second cow?
- 23 MR. HETTRICK: Yeah. We should have a
- 24 motion to, to buy a second trailer and cow as the
- 25 process permits, something like that, and that will let

us start work on getting it done. 1 2. CHAIRMAN COOK: Okay. A southern cow and a 3 northern cow. 4 COMMISSIONER COLLIER: Uh-huh. Well, Mr. 5 Chairman, I would move that we purchase, or we approve purchasing the second cow and trailer for the Southern 6 7 Marketing Area, and since we already have one for the 8 Northern Marketing Area. As soon as possible. 9 COMMISSIONER CROWTHER: Second. 10 MR. HETTRICK: Got a second. 11 CHAIRMAN COOK: Did I hear a second? 12 COMMISSIONER CROWTHER: Yes, second. 13 CHAIRMAN COOK: A motion and a second, and 14 no dissenting votes, so the motion carries. 15 MR. HETTRICK: All right. 16 CHAIRMAN COOK: We'll expand the herd. MR. HETTRICK: We will pass it on. We have 17 to learn how to say "Moolisa" with a southern accent. 18 19 COMMISSIONER CROWTHER: Lynn, it seemed like 20 when we got the first one it took awhile to get her put 21 together and, you know, obviously it's taken awhile to 22 get the trailer all set and ready to purchase. 23 any of that that we can start now on the second cow so 24 that come January we can just roll it right out and start using her? 25

And then they have, it 3 4 takes special shipping to get her out here. 5 incredibly well packaged. And that has to all be 6 arranged. 7 As soon as we get past July 1st -- he wants 8 to hold the purchase into January. But we, I believe we 9 can go ahead and order both the trailer and the cow and 10 have it ready for shipment. And probably order the cow, 11 actually, so it -- we'll have to wait until January 1 to 12 pay, and they won't ship until we pay, but then it takes 13 about seven days to get it. 14 COMMISSIONER CROWTHER: Okay. Perfect. 15 That was my question. Good. 16 CHAIRMAN COOK: We should probably look at 17 naming the Southern Nevada cow differently than the 18 Northern Nevada cow, and have a contest down there to 19 draw some attention and get some publicity. Maybe in 20 cooperation with Meadow Gold and Anderson and the other 21 schools, the district down there. 22 I'm game if somebody wants --MR. HETTRICK: 23 CHAIRMAN COOK: Well --24 MR. HETTRICK: I mean, we can take a run 25 at --

1 CHAIRMAN COOK: We've got a PR person 2. that --3 MR. HETTRICK: Yeah, we've got, we've got 4 our PIO who can see if we can work up something where we 5 can put together a contest for the school, or something. I don't know what they'll let us do. Schools often 6 7 aren't thrilled with us bringing in something else for 8 them to administer. But maybe we can come up with a 9 way, I don't know, to --10 COMMISSIONER CROWTHER: If there's something 11 even that they can go to our website and do it, or just 12 give the information to the schools to tell the kids to 13 go to our website, so, you know --14 MR. HETTRICK: I'll talk to the, I'll talk 15 to the PIO and see what we can do, what she feels like 16 we can arrange to do. 17 Go ahead, Gary. 18 MR. RECK: Gary with Model Dairy. I'm sure 19 Meadow Gold, I really can't speak a hundred percent, but 20 99 percent that they would be interested in helping. 21 used to be able to do side panels, and with enough time 22 we may still be able to do that. But at this time we're 23 not doing the school milk down there, but I know it's 24 coming up for bid. And if we were to win that bid, for 25 whenever reason, it would be a good thing. But I'm

- 1 certain that June would want to, want to help out in
- 2 some way.
- 3 CHAIRMAN COOK: Yeah. Great.
- 4 MR. RECK: If there's any way that we can
- 5 step in, regardless of the school bid, if there's
- 6 something that we can do to help --
- 7 MR. HETTRICK: Even on your, even on your
- 8 fluid milk sales down there, if we just went on what you
- 9 were selling in the markets.
- MR. RECK: It's pretty hard now, because
- 11 everything we do is in plastic. You know, we had the
- 12 paper half gallons and paper quarts. We still do paper
- 13 quarts up here, but those are going to go away as well.
- 14 With everything going to plastic, it's hard to put
- 15 anything.
- MR. HETTRICK: Yeah.
- 17 MR. RECK: There's really no side label to
- 18 use.
- 19 MR. HETTRICK: Yeah. So you were thinking
- 20 of the side label on the little --
- 21 MR. RECK: On the little eight ounce. Yeah.
- 22 We've got a little story on every one, a little question
- 23 type story. They can change that, for sure, depending
- 24 whatever time frame you wanted to do it.
- 25 CHAIRMAN COOK: Yeah, that's --

Well, let me talk to the PIO 1 MR. HETTRICK: 2. and pass all of that on, and then we'll see, kind of let 3 this work down the road. But that would be awesome. 4 CHAIRMAN COOK: Press release: Moolisa has 5 a sister now and --6 MR. RECK: I'm sure the competitor --7 CHAIRMAN COOK: -- name Moolisa's sister. 8 MR. RECK: I'm sure the competitor can 9 probably do the same thing. 10 CHAIRMAN COOK: You mean the other guys? MR. RECK: I won't mention any names. 11 12 CHAIRMAN COOK: The one that starts with an 13 "A." 14 MR. HETTRICK: All right. We'll pass that 15 We'll see. Yeah, I think it will be a good idea. on. 16 We'll try to do what we can to --17 COMMISSIONER CROWTHER: Also on the trailer, 18 and, I, I don't want to get ahead of myself, but the one 19 that goes up there, up to Northern Nevada, I know our 20 next meeting is in Fallon. Is that correct? 21 CHAIRMAN COOK: Yes. 22 MR. HETTRICK: Yes. 23 COMMISSIONER CROWTHER: The July meeting. 24 I, I would like to attend that meeting in Fallon, since 25 I haven't been up there for a long time. I could

- 1 probably hook onto that trailer and drag it up there
- 2 with my truck if, you know, that, if you think that
- 3 would be a good option.
- 4 MR. HETTRICK: I'll have to work, I'll have
- 5 to work on that for you, Troy, on a couple of levels. I
- 6 think we could have you tow it from Vegas to here, but I
- 7 believe we can't order it, and when I talked to him
- 8 last, he told me it was, it took seven to nine weeks to
- 9 do it. And I think our meeting is in July. You may not
- 10 have it in time to drag it --
- 11 COMMISSIONER CROWTHER: Right.
- MR. HETTRICK: -- before August. So we'll
- 13 just have to see. But if I can work the timing out, I
- 14 would be happy to do that and work out the ability to
- 15 drag it. Not an issue. But we've got to see if we
- 16 actually have it in hand, given the delay and we can't
- 17 spend money yet.
- 18 CHAIRMAN COOK: If not the July meeting, it
- 19 will be October.
- 20 COMMISSIONER COLLIER: Yeah.
- 21 MR. HETTRICK: Yeah, you could do -- well, I
- 22 don't know if we want to wait until October. And it
- 23 will depend on if somebody else is going down there or
- 24 not anyway, the truck is going anyhow. Because that
- 25 way -- if we send our truck, the fuel cost is just the

- 1 fuel cost. We don't have to account for the mileage and
- 2 all the, you know, pennies for mile and the forms. We
- 3 just expense the gasoline and it's over with. Because
- 4 that's a part of what we do. But if we go the other
- 5 way, then we have to go through all of the expense
- 6 report forms and justification and --
- 7 COMMISSIONER CROWTHER: Right.
- 8 MR. HETTRICK: -- yeah, all the rest. Which
- 9 it's probably -- I mean, it would be convenient and
- 10 quick if it were there, it would be great, if you could
- 11 do it in July, because we might not get somebody down
- there then, but we'd have to have the trailer and then
- just go through the work. But we've got to back up and
- 14 remember, this is the State.
- 15 CHAIRMAN COOK: Yeah, yeah. Yeah.
- MR. HETTRICK: So --
- 17 COMMISSIONER CROWTHER: Okay.
- 18 CHAIRMAN COOK: But you're still going to
- 19 come up in July for the Fallon meeting.
- MR. HETTRICK: Yeah, come up to the meeting
- 21 regardless. Talk to Kathy. She'll get you booked up.
- 22 COMMISSIONER CROWTHER: Yeah. Yeah, I'd
- like to. Let me know about the trailer as soon as you
- 24 find out. And then if I'm not going to do that, then
- 25 I'll talk to Kathy and we'll get a flight up there.

1 Well, I can't even talk to MR. HETTRICK: 2. them about ordering the trailer until July 1. 3 COMMISSIONER CROWTHER: Okay. 4 MR. HETTRICK: So --5 COMMISSIONER CROWTHER: Okay. I could get them to send me a 6 MR. HETTRICK: 7 price, but I can't tell them that we're going to buy a 8 trailer. 9 COMMISSIONER CROWTHER: All right. 10 CHAIRMAN COOK: Okay. 11 MR. HETTRICK: All right. Next on the 12 agenda, Mr. Chairman, is the staff report. Just wanted 13 to tell you that, to start, that Anna and I have been 14 talking. We're going to do some reviewing of the NAC. 15 We didn't do -- NAC is the Nevada Administrative Code. 16 We didn't do any statutory changes within Chapter 584, 17 which is the Dairy Commission, this time. If you 18 recall, we did those in 2013. 19 But now we, we feel like there's some 20 updates that we need to do in the administrative code 21 that backs up those regulations, or those statutes. And 22 so we're going to go through and review that. And when 23 we get all done with that review, we'll bring it to you 24 for your approval and questions about what we're doing 25 and why we're doing it and those kind of things.

- 1 just so you know that we're in the process of doing some
- 2 of that.
- It was brought up earlier, Kimberly
- 4 mentioned, Damon called me earlier today and said, "I
- 5 was printing off the fiscal report to give you today and
- 6 got looking at numbers and realized something was
- 7 wrong." And he said, "I went into Excel and realized
- 8 that one of the formulas that we have in that
- 9 spreadsheet is wrong." He said, "If I can get it done
- 10 and I'm absolutely satisfied that the numbers I'm going
- 11 to give you are correct, I'll be there in time to give
- 12 it to you. And if I don't, then I'll give you one that
- 13 I'm positive is correct next time."
- So obviously he's not here, so he's not
- 15 happy with what he's getting yet and absolutely positive
- 16 enough to provide it. There's not going to be any
- 17 significant change, I'm sure, because it's been running
- in the same trend all along. But he's a good CPA
- 19 auditor and he wants it to be perfect, so he didn't want
- 20 to bring it if it wasn't right.
- 21 CHAIRMAN COOK: Okay.
- MR. HETTRICK: And then finally, I sent all
- three of you commissioners an email yesterday, or the
- 24 day before yesterday, about IAMCA. And I did go and
- 25 talk to fiscal, and also to the director, and, and I do

- 1 want to point out, we are a part of the Department of
- 2 Agriculture, so to do these things we still have to have
- 3 approval of the director, regardless. And, and he was
- 4 perfectly happy. If you want to go to the IAMCA
- 5 meeting, you're welcome all to go. I think -- Troy,
- 6 have you gone before?
- 7 COMMISSIONER CROWTHER: I have.
- MR. HETTRICK: Okay.
- 9 COMMISSIONER CROWTHER: Chris and I have
- 10 been.
- MR. HETTRICK: Yeah. And you're all three
- 12 welcome to go, if you want to go. You know, it's,
- there's a registration fee, the State will cover that.
- 14 Your meals are pretty much provided while you're there,
- but you get a per diem for other than when you have a
- 16 meal provided within the registration fee. Your travel
- is covered for the time that you're there.
- I think you guys have expressed to me in the
- 19 past that you felt it was a good experience and
- 20 worthwhile. So if you have an interest, that
- 21 registration packet you should all three have. We
- 22 should register, I think it said June 25th.
- 23 CHAIRMAN COOK: Anybody from the staff going
- 24 to go?
- MR. HETTRICK: Anna might go. She's looking

- 1 at going so we have somebody there. They will have, on
- 2 the agenda, if you got to look at the packet, they will
- 3 have a discussion of Fairlife. And I know that's come
- 4 up, the Fairlife product that is being marketed here
- 5 now. And it might -- that's on one of their agenda. I
- 6 think it's the last day of the conference. Which might
- 7 be interesting just to have some more background about
- 8 the product and what their plans are and what they're
- 9 doing. So could be interesting. Good contacts.
- 10 CHAIRMAN COOK: Do you have any interest in
- 11 going to that?
- 12 COMMISSIONER COLLIER: I would like to go to
- 13 it, but I question should I go to it because of the
- 14 expense of it, and I think that money would be better
- 15 spent, you know, promoting the milk industry here in the
- 16 State of Nevada rather than sending me off to a big
- 17 conference.
- 18 MR. HETTRICK: And I appreciate your concern
- 19 and your interest in promoting, but you just approved
- 20 about, what, about ten, twelve thousand dollars -- no.
- 21 You approved about fifteen, sixteen thousand dollars'
- 22 worth of milk promotion in a trailer and a cow.
- 23 COMMISSIONER COLLIER: Well, I think
- 24 that's --
- MR. HETTRICK: No, more than that.

1 COMMISSIONER COLLIER: -- more important 2 than me going to a conference, quite frankly. 3 MR. HETTRICK: But frankly, you have the 4 money to do both in this situation that we're in right 5 And that is promoting milk. COMMISSIONER CROWTHER: I will tell you --6 7 can I just speak to that? When I was -- I had been on 8 the commission maybe a year or two when I went to the 9 IAMCA conference, and I learned more at that conference 10 than I have learned elsewhere, put together. 11 classes that are interesting and informational, and you 12 get a -- the perspective from people around the country, 13 and, quite honestly, around the world that are there, 14 you just learn a lot. And I, I feel like I was a better 15 commissioner after that for having gone. 16 COMMISSIONER COLLIER: Well, I would welcome 17 the opportunity to go, but I'm going to be out-of-pocket 18 this next week. I'm going to be out in the middle of 19 So if you want me to fill out a form or 20 something, I mean, I have to do it tonight at midnight. 21 So --22 MR. HETTRICK: Yeah, I think Kathy can help 23 you with filling out the basics of the form and 24 filling -- because a lot of it --25 COMMISSIONER COLLIER: I mean, if there's a

1 June 25th deadline, I mean, I --2. MR. HETTRICK: She can, she can do that. And I think ultimately we'll probably book the 3 reservations as well, because we'll book them through 4 5 the State and we'll get discounts. So pretty much Kathy will do all the dirty work for you. 6 7 COMMISSIONER COLLIER: So is Chris or --8 Chris, are you and Troy going to go? 9 CHAIRMAN COOK: I was initially intending to 10 go, but then my wife reminded me that I'm committed to a 11 60th birthday party celebration for my brother in 12 Florida that week, so --13 COMMISSIONER CROWTHER: I, that date is 14 probably about the busiest date in my professional year, 15 so I will not be able to do that. September 15th is a 16 horrible, horribly busy for me, and the days leading up 17 So no, I will probably not be able to go this to that. 18 year. 19 COMMISSIONER COLLIER: I'll be happy to go 20 and represent with Anna. Are you going to go? 21 Uh-huh. MS. VICKREY: 22 Yeah, I'll be happy COMMISSIONER COLLIER: 23 to go with you. 24 MR. HETTRICK: And if we don't have all three going, then I may talk about it, but I don't know 25

1 I thought it was far more important that Anna yet. 2 go --3 COMMISSIONER COLLIER: Uh-huh. 4 MR. HETTRICK: -- than me going. So, but 5 we'll see. 6 CHAIRMAN COOK: It is time and money well 7 spent. 8 COMMISSIONER COLLIER: Uh-huh. 9 MR. HETTRICK: It's not all that much money, 10 quite frankly. I mean, by the time you're done with the 11 whole thing, it would probably be a little over a 12 thousand dollars for each one who attends. It's not 13 that much money. It's \$400 for the registration, and 14 the hotels room are \$89 for three nights, and there's a 15 little bit of per diem, it really isn't very much, and 16 an airplane ticket. It just really isn't all that much 17 money. 18 So, I mean, we've been very frugal in this 19 commission. You guys have been incredible about the 20 money we've given back and the money we haven't spent, 21 and the money we do spend to help dairies with starlings 22 and to promote milk with cows and things like that. 23 think we've been very frugal and very supportive of the 24 industry, and I think this is helpful. I agree with 25 Troy, I think it's a good learning experience.

1 COMMISSIONER CROWTHER: I, I think 2. especially where, you know, Nevada is now part of the 3 world --4 MR. HETTRICK: Market. 5 COMMISSIONER CROWTHER: -- milk market, and 6 you get that perspective when you go to this. You get 7 more international perspective than I think you get, you 8 know, at least in these meetings or other things. And 9 I -- it would be beneficial this year. 10 COMMISSIONER COLLIER: Well, count me in. 11 I'll be happy to go. 12 MR. HETTRICK: We'll let Kathy work on 13 getting this stuff done --14 COMMISSIONER COLLIER: And you guys can 15 brief me and bring me up to speed. 16 MR. HETTRICK: All right. The only other 17 thing we have, then, Mr. Chairman, is you have the price 18 I think they were passed on out and they're sheets. 19 sitting in front of you. Prices are up a little bit, 20 but still lower than they have been. But this is steady 21 and I haven't heard anybody complaining bitterly, so it 22 is what it is. 23 CHAIRMAN COOK: Any updates on the --24 MR. HETTRICK: The last --25 CHAIRMAN COOK: -- operation, the -- are

1 they --2. MR. HETTRICK: The last I heard, they should 3 be up to -- what? They were 2,200 cows last meeting, 4 and didn't he tell us, didn't Al -- well, you weren't 5 here, I don't think. Al told us -- were you here last meeting? I don't remember. Al told us he thought they 6 7 would be 3,500 in, I thought he said a month. 8 presuming the cow numbers are continuing to go up. 9 Probably as they freshen cows. So they're probably not hauling in anymore. They've probably got cows to 10 11 freshen, and so they're increasing numbers slowly. 12 yeah, they were hauling two double -- what do they call 13 them, two double fours or double eights, or whatever, 14 out of there daily. 15 MS. VICKREY: Uh-huh. 16 MR. HETTRICK: That's how I understood it. 17 CHAIRMAN COOK: Yeah. They're moving cows 18 from an operation in California. 19 MR. HETTRICK: I think they moved in all the 20 cows. 21 I think they're all in now. MS. VICKREY: 22 MR. HETTRICK: And just as cows freshen 23 they're coming into the herd milking line. So, but I 24 think the cows are all on the property. That's just my 25 assumption, based on the way it's working and the way

that you -- cows don't freshen just because you want 1 2. them to. You have to have them, obviously, over time. 3 CHAIRMAN COOK: Right. 4 MR. HETTRICK: They had to make sure they 5 had a place to milk them. 6 CHAIRMAN COOK: That's good. Glad to hear 7 it. 8 MR. HETTRICK: So I think things are going 9 well there. I haven't heard anything negative 10 whatsoever. I haven't had any complaint from neighbors or anything since they've been there and operating. 11 12 Which is a good thing. I think it's a good thing. I 13 think it's settling down. 14 CHAIRMAN COOK: They're finding out it's not 15 as bad as their worst fears. 16 MR. HETTRICK: Yeah. 17 CHAIRMAN COOK: Well, I would like, at some 18 point, for us to make an official visit down there as 19 commissioners and thank them for choosing to come to 20 Nevada. 21 MR. HETTRICK: Yeah, being here. That would 22 be another -- if in the in the event, for any reason, 23 Troy, it doesn't work out for you to come in July --

HETTRICK: I think so. 4 CHAIRMAN COOK: Anybody else have anything 5 to throw out on the table for discussions for the record? 6 7 COMMISSIONER COLLIER: I have one thing I'd 8 like to just inquire -- well, actually, two things. Do 9 we have any kind of cheese processing here in the State 10 of Nevada? 11 MS. VICKREY: Yes. They don't -- we have 12 two small facilities that make their own cheese, and we 13 have a couple of what I call slice and dice facilities, 14 where they bring in large cheese blocks and shred it 15 and --16 COMMISSIONER COLLIER: Were they the ones 17 featured in that Edible magazine? 18 MS. VICKREY: One was, Pacific Cheese. Ιt 19 was just a small article. 20 COMMISSIONER COLLIER: Do they have to get a permit from the Dairy Commission? 21 22 MS. VICKREY: Yes. 23 COMMISSIONER COLLIER: Just like anybody 24 else. Okay. 25 MS. VICKREY: Yeah.

1 COMMISSIONER COLLIER: The second thing is, 2. the thought going through my mind is what, what would it take us, as a dairy commission, to put a coloring book, 3 4 or some kind of educational piece, distributed through 5 all the elementary schools in the State of Nevada about drinking milk? 6 7 Yeah. Anna's laughing. MR. HETTRICK: 8 COMMISSIONER COLLIER: Is there some reason 9 why we couldn't do something like that? 10 MR. HETTRICK: We're going to send you down 11 there and let you take the slings, arrows and bruises that I got when we did a coloring book and tried to 12 13 distribute it to the schools in 2013. We did that once. And we went to the legislature and told them we wanted 14 15 to spend \$200 to print coloring books, and they beat me 16 up royally for about two hours over the fact that we 17 were producing a coloring book and that we wanted to 18 take it to the schools. And one of the senators said we 19 had to, who was a former school teacher, said that we 20 had to go through the school administration and get it 21 approved, and that she would arrange for all of that to 22 be done within the schools down there in Las Vegas, and 23 on and on and on. And we finally said enough. It's not 24 worth it. 25 There are a myriad of those things around

- 1 out there. And even though ours was very generic, very
- 2 simple -- we printed it ourselves on black and white,
- 3 made the books up. Kathy made them. I mean, they
- 4 didn't cost probably, I don't know, \$0.10 apiece. It
- 5 was nothing. And they just complained bitterly about us
- 6 doing it.
- 7 So I think taking the cow is really better.
- 8 When we've taken the cow down to, like, Bordewich School
- 9 here, Bordewich Bray in Carson, it's incredible. We
- 10 haul that cow down there. We have 150, 200 kids come
- 11 out there and go through, talk about where milk comes
- 12 from. We took an FFA student along who spoke to the
- 13 kids. A young student. And it was a good experience
- 14 for them, and the kids listened to the young person
- 15 talk. And then they all got to milk the cow, takes
- 16 turns, come around, ask questions. They loved it.
- 17 We brought the cow home. We no more than
- 18 got home and we got a phone call from another teacher at
- 19 Bray Bordewich and said, "Can I have the cow come for my
- 20 class? My kids want it. They saw the cow and they all
- 21 want the cow too." Had to turn right around about two
- 22 days later, haul the cow back down there.
- It's the best thing you can do. It attracts
- 24 more attention, gets more interest. They see a lot of
- 25 coloring books, they don't see cows, and so --

1 COMMISSIONER COLLIER: Well, the cow, the 2. cow, I think, is very significant. I agree with you totally. I'm just trying to think of ways -- because 3 4 we, we're funded by the, the people who sell this milk, 5 and I think we ought to be doing everything we can to help them sell more milk, period. 6 7 And because milk is declining, I mean, as 8 you look at all the, like the almond milk and the soy 9 milk --10 MR. HETTRICK: I know. 11 COMMISSIONER COLLIER: -- and all these 12 articles that I read about it, I think that we need to 13 be promoting this industry more. And I'm really an 14 advocate of that. So --15 CHAIRMAN COOK: That's what we ought to put 16 in the trailer, is a dead almond tree and a dried up 17 soybean plant, and say milk doesn't come from there. 18 MR. HETTRICK: Yeah, that's what I was 19 thinking. 20 MS. VICKREY: Well, and I think something 21 that might be helpful too, like industry's comments, is 22 if we do take the cows out to the schools, is there a 23 possibility to bring out some milk from your facility 24 and hand out some milk while they're milking the cow? 25 That way they can kind of relate the two. I mean, that

- 1 might, that might help with promoting it. I don't know.
- 2 It would be kind of hard for us to, you know, hold milk
- 3 cold and give it out.
- 4 MR. RECK: Of course we would donate milk
- 5 for something like that, but -- you know, we might be
- 6 able to help with a refer for the trailer.
- 7 COMMISSIONER COLLIER: There you go.
- 8 MR. RECK: I mean, let's wait and see -- I
- 9 mean, if you know the specs of the trailer, you
- 10 certainly would want to have a refer in there. I don't
- 11 think -- dealing with ice would be a bad deal. But
- 12 yeah, absolutely.
- 13 COMMISSIONER COLLIER: Yeah, I think that
- 14 would be a significant thing.
- MR. HETTRICK: Having a refer in the trailer
- is a difficult thing because of the ability to keep it
- 17 running while you go, and have a big enough refer.
- 18 Otherwise, you're going to an RV style, butane, hauling
- 19 propane, butane to make it run while -- or else you have
- to run a generator the whole time you're running, which
- 21 it's not set up to have a generator run. It will hold a
- 22 generator on the tongue, but we would have to do some
- 23 mounting and put in our own generator and the like.
- 24 It's something we can look at.
- But I think we also have to go back and look

- 1 at the statute, and the statute says we can promote the
- 2 viability of the dairy industry. And I'm not sure that
- 3 they would be thrilled with us if it's, if we direct it
- 4 at any one segment. I know where the money comes from.
- 5 That happens to be where, in our system, it got set up
- 6 to function, in part, a great deal, and to this day a
- 7 good thing. Much as we'd like to sell much more milk in
- 8 the north for Model Dairy, the reality is about
- 9 70 percent of our milk here comes from out of state.
- 10 And every time we promote fluid milk, they benefit, and
- 11 they're paying for it. You know?
- 12 We understand, we're concerned about the
- whole industry more as the Dairy Commission and not one
- 14 segment. We do pretty much appreciate where the money
- 15 comes from, but we also have check-off from the dairymen
- 16 going to Nevada, or Nevada Utah Dairy Council, and their
- job is to promote fluid milk sales, not the viability of
- 18 the industry as a whole. So --
- 19 CHAIRMAN COOK: We don't want to get into a
- 20 situation where we create any rivalry.
- MR. HETTRICK: And we've been there, done
- 22 that with the Nevada Utah Dairy Council, and have
- 23 created a lot of grief. They feel like we're competing
- with them, and they don't get happy.
- So I appreciate, again, John, where you're

- 1 coming from. We very much appreciate your interest in
- 2 promoting the industry, but I don't think we want to go
- 3 into direct fluid milk promotion. I don't think we can,
- 4 but don't think we want to because of all the
- 5 situations --
- 6 CHAIRMAN COOK: Oh, but there's no reason
- 7 why, you know, as Gary said, that, okay, you're going to
- 8 be showing up at a school in Washoe County, that Model
- 9 Dairy couldn't roll up behind you with a truck, a refer
- 10 truck, with some milk to hand out.
- MR. HETTRICK: And whether they hand out
- 12 milk or not, I would love to have the milk truck there.
- 13 Even a tanker if it was empty. Anything.
- 14 COMMISSIONER COLLIER: Bring a, bring a semi
- 15 full of ice cream.
- 16 CHAIRMAN COOK: Bring one of the home
- 17 delivery trucks and --
- MR. RECK: We've been promoting that big
- 19 time. So, yeah, all of the above.
- MR. HETTRICK: Yeah. I mean, I think
- 21 anything that just sparks interest in kids and they
- think about it and, and, you know, they think about milk
- is a good thing.
- 24 COMMISSIONER COLLIER: On tax day here, I
- remember when you went to the post office and everybody

| 10 | of the industry, the Dairy Commission for the State of |
| 11 | Nevada? The great State of Nevada? Nothing? Okay.      |
| 12 | Well, then, let us adjourn this meeting.               |
